TREEQULHAQ LETTER NO TH/3 /PECA/AMMENDMENTS Dated _____

SUBJECT: AMENDMENTS IN “PREVENTION OF ELECTRONIC CRIME ACT” BY TREEQULHAQ INT’L

RESPECTED AND HONORABLE,

Assalamo Alykum

1. Anti-Islam and Anti-Pakistan conspiracy of NGOs is nowadays ON, to take down Islamic and Pro-Pakistani clauses from Prevention of Electronic Crime Act (PECA) to create a free space to ridicule our Beloved Prophet ﷺ. TREEQULHAQ and GOVERNMENT OF PAKISTAN will never let it happen انشاء اللہ. A Study named ‘Anti Islam & Anti Pakistan NGOs And their Role in PECA’¹ was carried out by TREEQULHAQ including recommendations and was forwarded to Govt. In this regard, TREEQULHAQ INTERNATIONAL was approached by PRIME MINISTER OFFICE to amend PECA in light of QURAN & SUNNAH. (Letter enclosed)
2. It was indeed a heavy responsibility but الحمد لله TREEQULHAQ came up and proved equal to the task to *assist GOVERNMENT OF PAKISTAN* in finalizing it.
3. We support PECA in its current form and congratulate PECA approval from National Assembly as-is. However, in order to strengthen it further we proposed some amendments. **FINAL Prevention of Electronic Crime Act (PECA)** inclusive of all proposed amendments by TREEQULHAQ **READY FOR APPROVAL OF SENATE** is attached as **APPENDIX ‘1’**.

4. **Amendments in Prevention of Electronic Crime Act (PECA) by TREEQULHAQ were admired vastly and accepted warmly, equally in all circles of Ulama, Lawyers, Educationists etc.** Few of their comments are attached as Appendix '2' which indicates **there is huge public and Ulama support for amendments proposed by TREEQULHAQ and Pakistani public is backing us.**
5. FINAL Pakistan Electronic Crime Act (PECA) is incorporation of following amendments:
- 31 Proposed Additional Clauses plus 27 additional Proposed Definitions By TREEQULHAQ along with Rationale are attached as Appendix '3'; and
 - 45 Proposed On-Bill Changes along with rationale including; 32 minor (corrections) and 13 major (6 corrections, 7 additions); are attached as Appendix '4'.
6. TREEQULHAQ has also translated PECA and its amendments in Urdu for ease of understanding for those who are not well conversant with English as well as to assist Govt in future by reducing man hours and precious time of Govt; since Supreme Court has issued Order issued to enforce Urdu as official language; federal government departments have been asked to translate their policies and rules in Urdu in three months. These are attached as ضمیمہ اول، سوم، پنجم .
7. Since, TREEQULHAQ² has toiled to draft this Act with utmost effort and devotion, just for very IDEOLOGY OF PAKISTAN; so **it is expected that these proposed amendments will be enacted with your kind support** ان شاء اللہ .
